SUMMARY

Environmental Incentives (EI) and their sub-contractor Ecometrix Solutions Group (ESG) will present on the draft Conservation Credit System Manual and draft Habitat Quantification Tool Scientific Methods Document. The Council should discuss and provide recommendations to EI and ESG for these documents to be submitted as part of the State Alternative of the Sub-Regional EIS to the BLM and USFS on February 28, 2014. These documents will provide the framework necessary to the BLM and USFS to conduct analysis on the inclusion of the Conservation Credit System (CCS). The CCS will be fully developed by December 31, 2014 and incorporated as part of the State Plan.

PREVIOUS ACTION

June 17, 2013. The Council gave SETT direction to develop a Request For Proposals that requests the use of existing metrics being successfully implemented elsewhere; a (short) contract term within 6 months, and that would result in a federal agency accepted product.

December 3, 2013. Environmental Incentives was hired as the contractor to develop the CCS for greater sage-grouse in Nevada.
