- WHEREAS United States Fish & Wildlife Service (USFWS) is considering listing the greater Regional Sage-Grouse (GRSG) as threatened and/or endangered under the Endangered Species Act of 1970; *and*,
- WHEREAS determination of listing by USFWS is imminent; *and*,
- WHEREAS listing the GRSG is based on habitat loss while prevention of listing is dependent on restoration of such habitat; *and*,
- WHEREAS the Endangered Species Act of 1970 has the power to and has proven to be economically devastating to areas where species have been listed as endangered; *and*,
- WHEREAS recognizing the critical importance of this expansive landscape to the citizens and natural resources of the Silver State, as well as to eleven western states, the Nevada Legislature codified into state law the Nevada Sagebrush Ecosystem Program and Corresponding Council ; *and*,
- WHEREAS the Nevada Sagebrush Ecosystem Council has adopted a state plan for the conservation of the Greater Sage-Grouse; *and*,
- WHEREAS the Sagebrush Ecosystem Council taps the talents of scientists and range managers, along with their respective agencies working in tandem to develop innovative solution in conservation;
- THEREFORE BE IT RESOLVED that the Nevada Cattlemen's Association and the Nevada Woolgrowers Association fully support the state of Nevada Greater Sage-grouse (Hen) Conservation Plan and its unaltered contents as the preferred alternative to an Environmental Impact Statement; *and*,
- BE IT FURTHER RESOLVED that the Nevada Cattlemen's Association and the Nevada Woolgrowers Association fully supports all efforts going forward to implement the Nevada State Greater Sage-grouse (Hen) Plan for bird conservation, including but not limited to litigation if needed.
