- 6. DISCUSSION AND POSSIBLE DETERMINATION OF THE SCOPE OF WORK THE COMMITTEE WOULD LIKE TO ADDRESS. THIS WILL FOCUS ON THE MECHANISMS FOR SHORT TERM AND LONG TERM MONITORING, THAT DOCUMENT THE EFFECTS OF MANAGEMENT OF THE LAND USES AND LAND MANAGEMENT THAT WILL DIRECTLY AND INDIRECTLY IMPACT SAGEBRUSH ECOSYSTEMS AND NEVADA LANDSCAPES. THIS WILL INCLUDE, BUT NOT BE LIMITED TO, POSSIBLE DEVELOPMENT OF A SELF-MONITORING PROGRAM FOR PUBLIC LAND GRAZING ALLOTMENTS IN CONJUNCTION WITH BLM AND USFS. *FOR POSSIBLE ACTION*
 - A. Discussion of current methodologies, and current activities being implemented by BLM and USFS. Representatives of the BLM and the USFS will begin this discussion with explanations of the current policies and practices.
 - B. Discussion of other aspects of Monitoring that the Committee would like to address.
- 7. DISCUSSION AND POSSIBLE CONSIDERATION OF NEEDED UPDATES TO THE NEVADA RANGELAND MONITORING HANDBOOK SECOND EDITION, AND THE RANCHERS' MONITORING GUIDE; AND POSSIBLE METHODS TO ACCOMPLISH ANY CHANGES NEEDED. *FOR POSSIBLE ACTION*
 - A. Discussion and consideration of the current handbook on rangeland monitoring and the accompanying monitoring guide. These documents, also referred to as "Educational Bulletins 06-03 and 06-04", are believed to be the current documents being used by BLM, USFS, and others, to monitor for effective ongoing management of the many resource values, conditions, and ecosystem functions of rangeland in Nevada -- *Dr. Sherm Swanson, co-author of the documents being discussed.*
