A. Dr. Jeanne Chambers will present on the on-going work by WAFWA's Fire and Invasive Initiative to develop a conceptual framework that provides a strategic approach to integrate landscape-scale and local, site-scale prioritization and decision tools for the restoration and conservation of sage-grouse habitat. This framework has been adopted by the BLM/ USFS for incorporation into the Sub-regional EIS. The Science Work Group has vetted this approach and agreed that it was a good direction for the State of Nevada to adopt as well. The Council may provide direction to the SETT to work in partnership with the BLM/USFS to continue developing this framework and adopt it as part of the State's approach on fire and invasives for sage-grouse conservation. – *Dr. Jeanne Chambers, USFS Rocky Mountain Research Station*
