2021 CCS Highlights To Date

Seventeen mitigation transactions have been finalized using the CCS since inception of the program, conserving nearly 18,000 acres for at least a 30 year term.

Seven mitigation transactions were finalized using the CCS so far in 2021. These accounted for nearly 1,400 additional acres conserved over the long term.

Three new credit projects had the HQT conducted in the field this Spring to quantify credits despite lack of a seed funding round, and two credit projects recently signed management plans to allow their credits to be sold. Annual monitoring was conducted on credit projects with signed management plans.

The SETT visited four ranches for Five Year Qualitative Assessments and conduct annual monitoring. Visits were also made to have face to face discussions with two other credit project families and a prospective credit producer while traveling.

Fifteen potential debit projects representing various industries began consulting with the SETT on potential mitigation obligations, 8 of which used the HQT in 2021.

Spring 2021 Credit Project Site Visits





The SETT also visited the Humboldt Ranch - Hot Lake Credit Project of Nevada Gold Mines to conduct a Five-Year Qualitative Assessment and have discussion on the CCS and the management of their project.





At Cottonwood Ranch, the SETT conducted a Five-Year Qualitative Assessment, had lengthy discussion on the CCS, their credit project, credit sales, and conduct annual monitoring while also participating in the Shoesole meeting.

The SETT met with four family members from the **Owl Creek Ranch** to discuss various topics and took a tour of their ranch on the Eastern slopes of the Ruby Mountains.

Three generations of Sorensen's met with the SETT to learn annual monitoring protocols so they could divide up and monitor 10,000 acres on Secret Pass Ranch.
