**1) CALL TO ORDER @ 8:30am; ROLL CALL**

**2) PUBLIC COMMENT**

**3) APPROVAL OF AGENDA –**

**\*ACTION** Approval of agenda for Friday, December 13, 2024. Member Tibbitts moved to approve the agenda for Friday, December 13, 2024; Member Molini second the motion. The motion was approved.

**4) APPROVAL OF MINUTES –**

**\*ACTION** Approval of minutes from the subcommittee meeting held on Tuesday, September 24, 2024. Member Boies moved to approve the minutes and Member Davis seconded the motion. The motion was approved.

- a. Member Tibbitts stated a mistake in the title given to the DAG Ting, to be corrected by SETT.

**\*ACTION** Approval of minutes from the meeting held on Thursday, September 26, 2024, with edit made to DAG Ting's title. Member Johns moved to approve the minutes and Member Lister seconded the motion. The motion was approved.

**7) SUGGESTIONS TO INCREASE EFFECTIVE COMMUNICATION**

- a. Mr. Kim Summers, Credit Project Proponent for the RDD Credit Project at Knott Creek Ranch, along with his legal representative, Paul Taggart discussed more efficient and effective methods to communicate with proponents.
- b. Among these methods to consider were:
  - i. Listening sessions with stakeholders across the state on both the credit and debit side.
  - ii. Potential termination is done through proper noticing process.
  - iii. Cancellation only done by the committee and to have a hearing to do so
- c. Council members held discussion about listening sessions for proponents, the termination process, and recommended the SETT present on the credit process at a future meeting.

**8) REVIEW THE CURRENT PROCEDURES FOR COMPETING LAND USES, VERSION CONTROL, AND FINALIZING A DEBIT PROJECT; AND DISCUSS POSSIBLE CHANGES TO THE PROCEDURE**

- a. C. Acevedo presented a NEPA overview in respect to the CCS, current CCS policies, and options for possible adoption.
- b. Member Lister thanked Cheyenne for the presentation and asked for her to explain the options that are inverse to the current policy.
- c. Member Lister asked for Cheyenne to walk the council through the implications of each option.
- d. Member Raby asked for Cheyenne to walk him through the term "Competing Land Use" as it pertains to SETT projects.
- e. Member Boies asked about how the SETT determines how colocation of anthropogenic features, specifically about powerlines, would affect debits.
- f. C. Acevedo suggested that the SETT takes the council through the HQT process at a later meeting.

- g. Member Tibbitts asked for clarification from the Bureau of Land Management on the start of the NEPA process. Discussion was held between the Council and the BLM about the specifics of the timeline.
- h. Member Lister asked C. Acevedo when the projects that only have an EA come to the SETT to mitigate.
- i. Member Tibbitts asked C. Acevedo what maps the new projects, running under an EA, are using since the Council approved the new HMAs.
- j. Member Lister asked when the current HQT version is finalized.
- k. Member Lister asked about procedures projects with SERs.
- l. Member Swanson recommended that once a project enters the CCS, they should know what version they will be running under.
- m. Member Swanson proposed an idea that a debit project be able to choose if they wanted to use the new science or stick with the version that they enter into the SEP at. Discussion was held over this concept.
- n. Member Lister asked a question about the differences between the options, as it pertains to the advantages of not having land use, version, and entering the CCS at one time.
- o. Member Lister asked if there would be heartburn if the final version was not set until the ROD would be signed. Discussion occurred, with the council agreeing that there would be.
- p. Member Davis asked how long the current process has been in place and stated that the current process does not align with the current NEPA process.
- q. Member Davis asked if the program needed to tie specific parts of this process to the NEPA process.
- r. Member Davis proposed tying entering into the CCS at "End of Milestone 1" in the BLM's NEPA process. Discussion was held.
- s. Member Tibbitts proposed a motion to ensure that BLM makes SETT a Cooperating Agency for every project. Discussion was held.
- t. Member Davis asked who serves on the Technical Review Group/Science Working Group and what their role was.
- u. Member Davis shared his concern for the potential impacts to the Debit Project Proponents and his support for Member Swanson's suggestion to allow debit projects to choose when they wanted to lock the HQT version in.
- v. Discussion was held over competing land use.
- w. Member Davis suggested that projects enter CCS at time of their baselines being completed. Discussion was held.
- x. S. Monaghan explained benefits to credit projects if competing land use is moved towards later parts of the NEPA process.

**\*ACTION** Member Swanson motioned that the SEC support option 3 with flexibility for version changes based on if the science changes, as the proponent's choice, and that competing land use will apply at the end of final public comment. Member Emm Hooper seconded. All were in favor.
